All data is stored securely within the UK or EEA, or in jurisdictions with adequate data protection safeguards.

We may share limited personal data with:

- Regulatory or legal authorities where required by law.

We do **not** sell or trade personal data to third parties.

7. Data Retention

We retain personal data only for as long as necessary to fulfil the purposes for which it was collected, including any legal, accounting, or reporting requirements.
